INSTRUCTIONS FOR NOMINATION

ELIGIBILITY REQUIREMENTS

Who: Any person, alive or deceased, who has made outstanding and notable contributions to clinical engineering (CE) can be nominated for the CE-HOF, regardless of age, sex, race, nationality, residency, education level, years of experience, and membership within ACCE (i.e., non-ACCE members are acceptable). A person cannot be inducted to CE-HOF based on a single achievement, extended period of service, or any contribution that can be considered as normal and expected from his/her employment or assignment. Furthermore, none of the accomplishments presented to support the nomination can be less than 10 years old, so it is clear that those accomplishments stood the test of time. Self nominations will not be accepted.

Eligibility Criteria: For an individual to be eligible for induction, the contributions made by the candidate must meet one or more of the following criteria:

- <u>Impact</u>: The contribution has significantly impacted the development or growth of CE and continues to demonstrate relevance to the profession's continual advancement and evolution.
- <u>Influence</u>: The contribution has significantly influenced: i) the work of others in the field; ii) the healthcare industry; iii) society at large, regardless of country or region of the world.
- <u>Innovation</u>: The contribution has challenged the status quo and entrenched misconceptions with original thinking / creativity through: i) introduction of new concepts, methods, or tools; ii) removal or reduction of obstacles; or iii) enhancement of safety and reliability of medical equipment.
- <u>Reach</u>: The contribution has significantly impacted large amount of current and prospective CE professionals, clinical users, regulatory authorities, patients, and society at large.

NOMINATION PACKAGE

Nomination Submission:

- Provide a detailed <u>one page</u> narrative about the nominee, in addition to the Nominee Data Sheet. The narrative should address how the nominee has met one or more of the criteria noted above.
- Letters of support from at least three well-known CE professionals, <u>other than the Nominator</u>, are to be submitted in support of the nomination.
- The candidate nomination package must be received by ACCE on or before February 17. Any nomination package received after the deadline will be considered the following year. Please send the package to the CE-HOF committee at: CE-HOF@accenet.org

Nomination Hints: Although acceptable as evidence of accomplishments, the following items are not sufficient by themselves for induction into the CE-HOF:

- Awards, honors, patents, decorations, etc.
- Published editorials, articles, book chapters, books, etc.
- Lectures, keynote speeches, presentations, etc.
- Certifications, association memberships, etc.
- Leadership position in organizations, companies, associations, etc.

Please ensure that at least these questions are addressed properly in the nomination package:

- Which were the nominee's most significant achievements?
- When and where did the nominee make his or her significant contributions?
- How have the nominee's contributions benefitted and are still benefiting today patients and/or other healthcare professionals?
- What distinguishes the nominee from others in the same field?

The CE-HOF Nominating Committee looks forward to receiving your complete, documented, and concise nomination package for consideration.
